## How the Rally Works:

You can earn a trip to Nashville by building and strengthening your business through duplication in your team. This is a rally based on business volume ('BV') produced by all **NEW 4-Level Personally Enrolled Team members (4PET)** who enroll during the contest period.

<ul style="list-style-type: none"> <li><b>Create your team:</b> Bring together your team of four (4) and select a team leader. Teams can only have two Directors or above (based on recognition rank) per team.</li> <li>The <b>Top 4 teams and Top 4 individuals</b> from Team 4 and beyond with the highest BV generated from the NEW 4PET will qualify for the Tier 1 Prize</li> <li>In order to qualify for a winning spot, your new 4PET must produce a combined <b>minimum of 7,000 BV</b>. Even though you may be ranked in the Top 4 teams, you will not be eligible to win unless you reach this minimum threshold.</li> <li>Members <b>must enroll a minimum of 6 new Personally-Enrolled Associates with a minimum of 100BV</b> during the contest period.</li> </ul>	<ul style="list-style-type: none"> <li><b>Top 30 individuals</b> subsequently will qualify for Tier 2 prize.</li> <li>In order to qualify for a winning spot, your new 4PET must produce a combined <b>minimum of 4500 BV</b>. Even though you may be ranked in the Top 30 individuals, you will not be eligible to win unless you reach this minimum threshold.</li> <li>Members must <b>enroll a minimum of 6 new Personally-Enrolled Associates with a minimum of 100BV</b> during the contest period.</li> </ul>
<ul style="list-style-type: none"> <li>No single member of your new 4PET may contribute more than 75% of your total 4PET volume during the contest</li> </ul>	

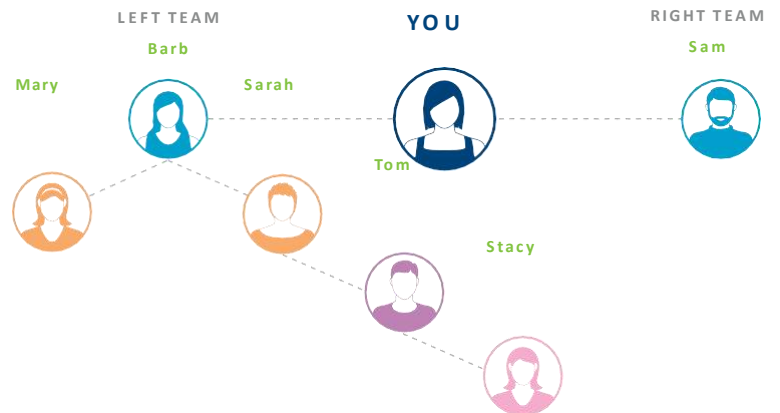
## Building Your 4PET (4-level personally enrolled team)

To participate in the Rally, you will need to build a new 4PET - you enroll a new Associate, who then enrolls a new Associate and so on until the new team has four level beneath you. Any of your personally enrolled team members who were enrolled prior to the start of the Rally will not be included in your IsaRally 4PET – these must be completely new enrollments. (See FAQs for additional details).

### 4PET Example

You enroll Barb and Sam. Barb enrolls Mary and Sarah. Sarah enrolls Tom. Tom enrolls Stacy.

LEVEL	First	Second	Third	Fourth
TEAM MEMBER	Barb, Sam	Mary, Sarah	Tom	Stacy

### FREQUENTLY ASKED QUESTIONS

#### DOES EACH TEAM NEED A TEAM LEADER?

Yes, the Team Leader is responsible for team creation, conference call updates, creating weekly goals, and also facilitating team communication. The Team Leader also serves as the main point of contact for all IsaRally updates from Isagenix Corporate.

#### CAN THE TEAMS BE CHANGED?

You cannot add or replace any team members after the registration period has closed. A team member may opt to permanently withdraw from a team by contacting Customer Care, however they cannot be replaced. Team Leaders have the ability to make team changes in their Back Office.

#### HOW DO I QUALIFY IF I DON'T HAVE A TEAM?

Yes, you may race towards the Top 4 individual spots in Tier 1 or Top 30 individual spots in Tier 2 of this IsaRally Contest.

#### DO NEW ENROLLMENTS MADE BY MY CURRENT 4PET (EXISTING 4PET PRIOR TO THE CONTEST PERIOD) IN THE CONTEST PERIOD COUNT TOWARD MY QUALIFICATION?

No, each member starts with a brand new 4PET at the time of the contest.

#### Example of Building Your New 4PET

Building on the previous example, Barb, Sam, Sarah, Tom, and Stacy were previously enrolled before the contest began, so they do not count towards your qualification. Although, Bob was enrolled by Mary after the contest began, he still would not count towards your qualification because Mary was previously enrolled. To create qualifying volume in the contest, you enroll James as a personally-enrolled team member. James enrolls Ann. Ann enrolls TJ. TJ enrolls Katie. All of the volume generated by these members during the contest will count towards your qualifying volume.

#### CAN MY EXISTING ASSOCIATE BV BE CONSIDERED AS PART OF THE 4PET REQUIREMENT?

No, only BV from new 4PET at the time of contest is considered.

#### WHEN CAN I GET STARTED BUILDING MY 4PET AND ACCRUING BV?

BV for your new 4PET accrues from 26 February 2018, 12:01am (US EST) until 3 June 2018, 11:59pm (US EST). BV accrues cumulatively during the contest period. Each new Associates you enroll must fulfil the following:

- Be 18 years or older.
- Be a citizen or tax-paying resident of their home market.
- Have paid their own membership fee on the Isagenix website.
- Have met all other enrollment criteria in the Policies and Procedures.

#### HOW CAN I KEEP TRACK OF MY 4PET BV?

BV generated by your 4PET will be conveniently displayed in your IsaRally individual report in your Back Office. You can view the report by visiting the "Reports" section under "Contests & Promotions."

### HOW DO PRODUCT RETURNS AFFECT MY BV TOTAL?

Any product returns will be deducted from your overall BV total after a return order is received by our returns warehouse and processed at the Isagenix Corporate Office.

### WHAT IF ONE OF MY 4PET MEMBERS IS IN AN INTERNATIONAL MARKET?

As long as you have your International Sponsorship, all BV in 4PET will be counted regardless of the enrolling country. For more information about International Sponsorships, please visit [IsagenixBusiness.com](http://IsagenixBusiness.com).

### DOES THE BV ONLY COUNT FROM THE 6 NEW ASSOCIATES AND THEIR TEAMS (WITHIN 4PET) TOWARDS ISARALLY?

No, BV counts from all of your NEW 4-Level Personally Enrolled Team members (4PET) who are enroll during the contest period.

### WHAT WILL HAPPEN TO MY TEAM IF ONLY 3 PERSON COMPLETE 7,000BV.

If your team is within the Top 4 teams, and team members who meet the requirement of a minimum 7,000BV, and have enroll 6 or more new Personally-Enrolled Associates will qualify for the trip to Nashville.

### CAN I REGISTER ONE OF MY 4PET AS THE TEAM MEMBER?

Yes, you can form a team with any Associate, Consultant, Manager, Director, and/or Executive (Based on highest recognition rank achieved historically with Isagenix).
