How the IsaRally Works:

You can earn a trip to Nashville by building and strengthening your business through duplication in your team. This is a rally based on volume produced by all **NEW 4-Level Personally Enrolled Team** (4PET) members who enroll during the contest period.

1. CREATE YOUR TEAM

Teams can have a maximum of two Directors or above per team. Each team can have a maximum of five team members. All five members of a winning team may qualify for a spot if they meet the minimum individual 4PET 7,000 BV qualification.

2. EARN TEAM POINTS

Help new Customers and Associates join Isagenix and grow your 4PET.

3. QUALIFY FOR YOUR SPOT

The top 10 teams whose combined 4PET generates the most volume during the contest period, as well as the top 10 individuals who are not on a top 10 team, will win the prize! Additionally, if you are a member of a winning team or a top 10 individual not on a winning team, you must have also generated a minimum of 7,000 BV in your 4PET during the contest period.

Building Your 4PET

To participate in the rally, you will need to build your business by generating sales in your 4PET. Here's how it works: You generate volume in your 4PET from purchases by anyone you enroll (1PET), anyone enrolled by a Member of your 1PET (2PET), anyone enrolled by a Member of your 2PET (3PET), and anyone enrolled by a Member of your 3PET (4PET). Any of your Personally Enrolled team members who were enrolled prior to the start of the rally do not count toward this promotion – these must be completely new enrollments. (See FAQ for additional details.)

Additional Rally Rules

- The top 10 teams and top 10 individuals who are not on a top 10 team in Canada are eligible to win the trip.
- To qualify for a winning spot, you and your new 4PET must produce a combined minimum of 7,000 BV. Even if you are a member of a top 10 team, you will not be eligible to receive a prize unless you reach this minimum threshold.
- In addition to the other requirements, you must enroll a minimum of six new Customers during the contest period to qualify to earn a prize.
- No single Member of your new 4PET may contribute more than 75 percent of your total 4PET volume during the contest period.

Frequently Asked Questions

How do I register?

Registration is from April 1, 2019, to April 21, 2019. Registration will not be available after this time. To create a team and become a team leader, you must be an active Consultant or above. Log in to your Back Office, go to the Contests & Promotions tab, and click View Contest to enter all team details.

Who can I have on my team?

You can have a mix of Associates, Consultants, Managers, Directors, and Executives on your team totaling a maximum of five Members. At the time of registration, only two team members may be a Director or above. Team members do not have to be Members of your organization. Points are cumulative, and it is best to fill all five spots on your team to accumulate maximum points. All five team members may qualify if they achieve their individual 7,000 BV in their 4PET.

Does each team need a team leader?

Yes, the team leader is responsible for the team creation, conference call updates, weekly goals, and team communication facilitation. The team leader also serves as the main point of contact for all IsaRally updates from the Isagenix corporate team.

Can the teams be changed?

You cannot add or replace any team members after the registration period has closed. A team member may opt to permanently withdraw from a team by contacting Customer Care; however, they cannot be replaced. Team leaders have the ability to make team changes in their Back Office.

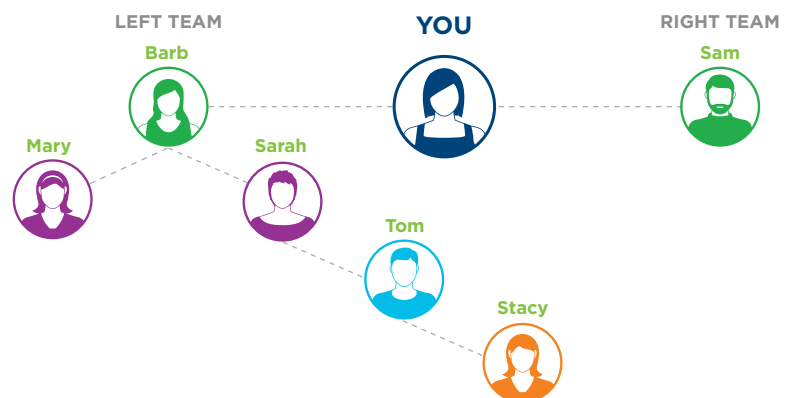
What is a 4PET?

A 4PET is four levels of an Associate's Personally Enrolled team.

4PET Example

You enroll Barb and Sam. Barb enrolls Mary and Sarah. Sarah enrolls Tom. Tom enrolls Stacy.

LEVEL	First	Second	Third	Fourth
TEAM MEMBER	Barb, Sam	Mary, Sarah	Tom	Stacy

Do new enrollments made by my current 4PET in the contest period count toward my qualification?
 No, for the purposes of this promotion, each Member starts with a brand-new 4PET at the time of the contest.

Example of Building Your New 4PET

Building on the previous example, Barb, Sam, Sarah, Tom, and Stacy were previously enrolled before the contest began, so they do not count toward your qualification. Although Bob was enrolled by Mary after the contest began, he still would not count toward your qualification because Mary was previously enrolled. To create qualifying volume in the contest, you enroll James as a Personally Enrolled team member. James enrolls Ann. Ann enrolls TJ. TJ enrolls Katie. All the volume generated by these Members during the contest will count toward your qualifying volume.

When can I get started building my 4PET and accruing BV?

BV for your new 4PET accrues from April 1-June 23, 2019. BV accrues cumulatively during the contest period. New Customers and Associates you enroll must qualify by meeting the following requirements:

- Be 18 years or older.
- Be a citizen or tax-paying resident of their home market.
- Have paid their own membership fee on the Isagenix website.
- Have met all other enrollment criteria in the Policies and Procedures.

How can I keep track of my 4PET BV?

BV generated by your 4PET will be conveniently displayed in your IsaRally individual report in your Back Office. You can view the report by visiting the Reports section under Business.

How do product returns affect my BV total?

Any product returns will be deducted from your overall BV total after a return order is received by our returns warehouse and processed at the Isagenix World Headquarters.

What if one of my 4PET members is in an international market?

As long as you have your International Sponsorship, all BV in 4PET will be counted regardless of the enrolling country. For more information about International Sponsorships, visit IsagenixBusiness.com.

What if my account is under compliance review?

Compliance matters will affect your eligibility to participate in IsaRally and may lead to immediate disqualification from the contest. If your account is under compliance review at any time during the contest and you are found to be acting in a noncompliant manner, or in a manner which Isagenix believes does not fit in the spirit of the contest, you may be disqualified from the contest.

If I finish in the top 10 and have reached the minimum BV and new Member threshold, how can I claim my prize?

The top 10 teams and top 10 individual winners will be announced in the month after the contest closes. Up to one prize per winning account will be awarded, which includes accommodations for four nights in Nashville from Aug. 10-13, 2019, a total of CA\$1,000 towards airfare costs to Nashville, a Global Celebration ticket for you and a guest, and other fun perks. The prize is nontransferable, and no cash equivalents will be given if the winner(s) cannot attend. Do Customers and Associates count toward my new 4PET volume?

Yes, any purchases by new Customers and Associates in your 4PET will count toward the IsaRally volume requirement.

RSVP

Do I need to RSVP to receive a prize?

Yes. If you qualify for a prize, you will receive an email by July 5, 2019, to RSVP. You must complete the RSVP by July 12, 2019. We are unable to accept RSVPs after the completion deadline.

Do I have to complete a Prize Acceptance Form to receive a prize?

Yes, if you qualify for a prize through this promotion, you will receive a Prize Acceptance Form with instructions to RSVP. You must complete and return the Prize Acceptance Form when completing your RSVP.

HOTEL

What can I earn from the hotel incentive?

Isagenix is covering the room cost and tax of a standard hotel room for up to double occupancy at a Nashville hotel for the dates of Aug. 10-13 (four nights). Any changes, additional nights, and other charges will be your responsibility. Hotel assignment will be determined closer to the event date.

If I cancel my existing reservation and move to the room, will I receive a refund?

As stated in the hotel reservation policy listed on the Global Celebration website, the first night's room cost and tax is nonrefundable.

When will I receive my hotel confirmation number?

Hotel confirmation emails will be sent approximately two weeks prior to the event.

What if I need to extend, upgrade, or make changes to my reservation?

If you wish to make any changes to your reservation (dates of stay, bed type, etc.), you may do so directly with the hotel once you receive your confirmation number. Please note: You are responsible for the costs of any upgrades, extensions, and other changes. The prize from this promotion can ONLY be used for the nights of Aug. 10-13. If you wish to arrive earlier or stay later, you will not be able to use the prize from this promotion to cover the cost of those nights. You are responsible for the cost of all nights outside of the dates mentioned above.

When will I receive the CA\$1,000 travel bonus?

Provided you complete your RSVP and submit your Prize Acceptance Form by the July 12, 2019, deadline, the CA\$1,000 will be paid via your commissions by July 29, 2019.

Can I choose my hotel?

Isagenix will choose your hotel, and requests will not be accepted.

What if I want to transfer to a different hotel?

Isagenix will only cover your stay in your assigned hotel.

Can I transfer my hotel reservation to someone else?

Yes, if you are unable to utilize your hotel reservation, you can transfer it to another name by contacting the hotel directly.

If I am gifting all or a portion of what I earned as part of this promotion, will I still be taxed?

If you receive an incentive through the IsaRally Nashville promotion, Isagenix will report the full value of the incentive as income, even if you use only a portion of the incentive or otherwise gift or transfer all or a portion of the incentive. You will not receive a cash equivalent or alternative prize for any unused portion of the incentive. Consult your tax professional to ensure income is properly reported.

What if I can't come or already booked my stay? Can I trade the hotel stay for cash?
